W.P. Carey Foundation Matching Challenge Reached

The historic naming gift of \$30 million from the Carey Foundation carried with it a matching obligation to raise another \$15 million by 2020. This was both a challenge and an opportunity. The matching gift enabled us to connect with our dedicated alumni to satisfy an ambitious yet achievable common goal. The funds we have raised, combined with the Carey Foundation commitment, will allow Maryland Carey Law to assume even greater prominence among law schools and within the broader legal community. 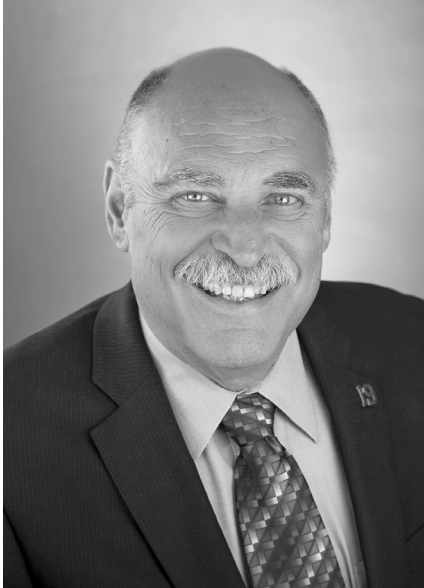

Maryland Carey Law Partners with UMB Foundation for Scholarship Matching Program

Last year, the University of Maryland Baltimore Foundation, Inc. (UMB Foundation) joined forces with the University of Maryland, Baltimore to raise a scholarship endowment of \$15 million. The income generated by this endowment will benefit each unit within the university. In addition, through a Scholarship Matching Program, the Foundation will match gifts by 50% up to \$750,000 per year for a two-year period, totaling \$1.5 million. Thus far, the law school has raised \$1.2 million toward its \$1.5 million goal, with a corresponding match of \$600,000. If we raise another \$300,000, we will then receive the benefit of the remaining \$150,000 match for this period.
