Advocacy-Coalition Framework

- Multi-Dimensional Policy Networks

- Key issues

- the ways in which interest groups interact with regimes and
- the ways in which interest groups forum shop to achieve their desired result

- Transnational Network Governance

- Key issues:

- relations between regulators and other government agencies at the international level and
- the ways in which they cooperate to create governance networks

A Return To Whaling?

- Establishment of alternative normative context – North Atlantic Marine Mammal Commission
- Scientific advice
- Whale watching
 - Global potential US\$ 2.5 billion in yearly revenue & 19,000 jobs
 - By 2000 approximately 86% of whale watching was taking place within the jurisdiction of IWC members
 - Latin America
 - between 1998 and 2006 whale watching increased by 11.3% a year

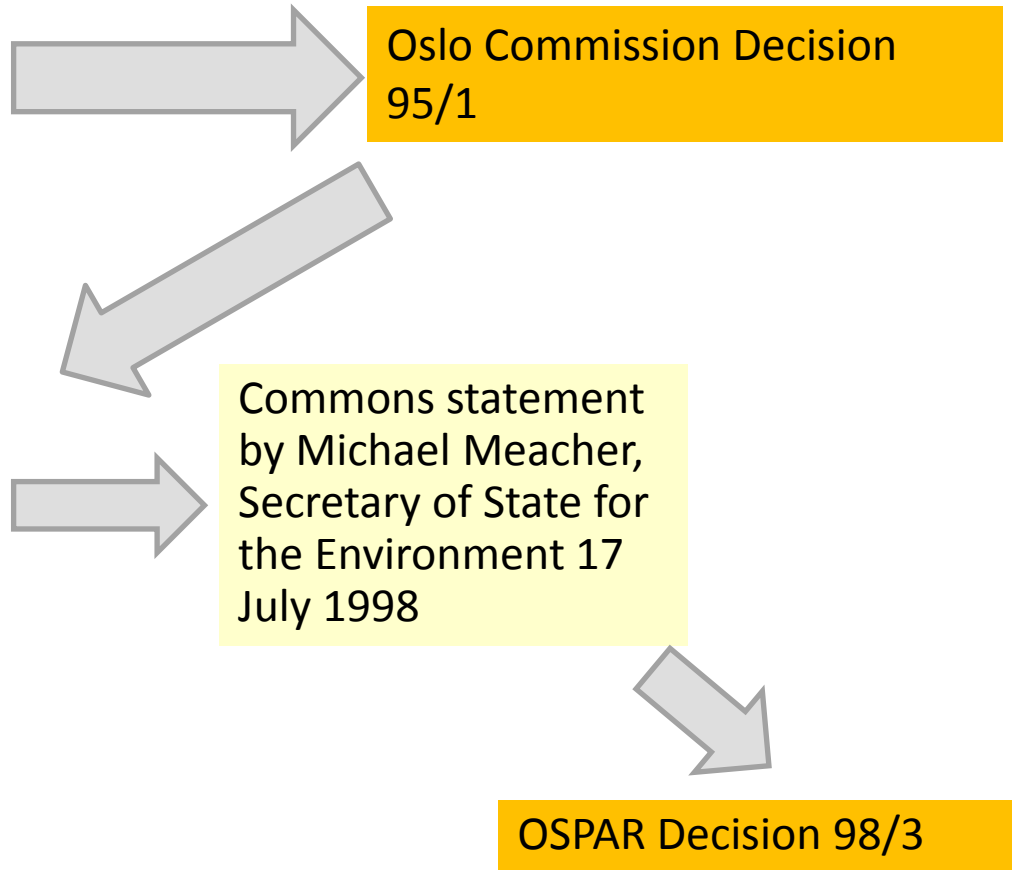

Conclusion
