CORRECTION OF AN ERROR

In the February, 1939 issue of the REVIEW, at page 146 of this volume, there appeared an error in describing the name of the appellant in a case there referred to. having no connection with the *Metropolitan Savings Bank* of Baltimore, Maryland. The REVIEW regrets having made the error, and takes this means of calling to the attention of its readers the fact that the *Metropolitan Savings Bank* was not involved in the case under discussion.

NEWS OF THE LAW SCHOOL

The Fifth Annual Law School banquet was held at the Chesapeake Club on Saturday evening, April 22nd, 1939. The banquet was held in honor of Hon. Henry D. Harlan, former Chief Judge of the Supreme Bench of Baltimore City, and Dean Emeritus of the Law School. A principal feature of the occasion was the presentation to the Law School of a portrait of Judge Harlan, presented by the alumni of the school, and painted by the New York artist, Mr. J. H. Gardner Soper.

Hon. Eli Frank, Associate Judge of the Supreme Bench of Baltimore City, and Lecturer on Torts at the Law School, served as toastmaster. The address in presentation of the portrait was made by Charles McHenry Howard, Esq., of the Baltimore City Bar and a member of the Faculty Council of the Law School.

Dr. H. C. Byrd, President of the University, accepted the portrait on behalf of the University, and addressed the gathering in connection therewith. Other addresses were by the Hon. W. Calvin Chesnut, United States District Judge, and Lecturer on Federal Procedure in the Law School, who spoke on Judge Harlan's career as a lawyer, judge, and teacher; and by the Rev. Dr. Don Frank Fenn, Rector of the Protestant Episcopal Church of St. Michael and All Angels, Baltimore, who spoke of Judge Harlan's services to the community as a citizen and a churchman.

The graduating classes presented to the Law School an oil painting copy of a portrait of Luther Martin, the famous Maryland lawyer of the early nineteenth century. Dean Roger Howell of the Law School accepted the gift on behalf of the School and also announced the names of

those elected to the Maryland Chapter of the Order of the Coif, national honorary society for scholarship in law. These include the Hon. Eli Frank, elected to honorary membership in the Order, and the following members of the graduating classes, elected to membership by virtue of their standing in scholarship in the courses taken in the School:
