## CONCERNING THE REVIEW

Taylor, Jr., of the Second Year Day Class; and Charles C. Atwater, of the Second Year Evening Class. Those of last year's Board who are still in school are also serving this year.

Professor G. Kenneth Reiblich is now serving as Assistant Editor and Business Manager of the REVIEW in place of Mr. Herbert M. Brune, Jr.

### NEWS OF THE LAW SCHOOL

The enrollment in the Law School for the current academic year is 242, of whom 142 are in the Evening School and 100 in the Day School. The entering Evening School class includes 54 and that of the Day School has 35. Of the entire student body, 60% are residents of Baltimore City, 35% of the Maryland counties, and 5% of other States. Of the student body, 20% had their pre-legal training at the University of Maryland and 80% had theirs at 55 various other colleges.

Mr. Alfred Bagby, Jr., Lecturer on Testamentary Law, who had lectured at the School since 1913, and who had taught at the Baltimore Law School from 1898 to 1913, retired from his teaching duties at the close of the 1937-1938 session. Mr. Bagby had reached the retirement age established by the University regulations. He now assumes the rank of Professor Emeritus.

Mr. Herbert M. Brune, Jr., who served during 1937-1938 as Associate Professor Law, has resigned from the faculty to devote his entire time to his practice.

Mr. Bridgewater M. Arnold, Assistant Professor Law, who was on leave of absence during 1937-1938 because of illness, has returned to the School and is again offering the courses in Partnership, Sales, and Creditors' Rights.

Mr. Frederick W. Invernizzi, A.B., LL.B., University of Maryland, who taught Mr. Arnold's courses during the latter's absence last year, has joined the faculty on permanent status as Instructor in Law. Mr. Invernizzi will conduct the courses in Equity, Equity Pleading, Negotiable Instruments, and Testamentary Law.

The courses in Suretyship and Mortgages are being offered this year by R. Dorsey Watkins, Esq., of the part-time faculty; and the course in Taxation is being offered by George Gump, Esq., also of the part-time faculty. Dean Roger Howell is teaching the new course in Administrative Law.

Since the completion of the book stacks and the consequent re-shelving of the Library, considerable progress has been made in developing the collection of books. With the acquisition of the Maine and New Hampshire Reports, the Library's collection of reports of American courts of last resort has become complete. The Illinois Appellate Reports have recently been purchased and the Library plans, as fast as is possible, to fill the few remaining gaps in the collection of American intermediate appellate and trial court reports. The periodical collection has been considerably improved, with the result that the School now has complete files of forty-one legal periodicals, and has fifteen more which are complete as far as the back numbers are currently obtainable. In addition, the Library currently receives and/or has broken sets of some thirty other journals.
