## CONCERNING THE REVIEW

### NEWS OF THE LAW SCHOOL

The enrollment in the Law School for the current academic year is 227, of whom 103 are in the Day School, and 124 are in the Evening School. The entering Day School class includes 42 and that of the Evening School has 38. Of the entire student body, 56% are residents of Baltimore City, 37% of the Maryland counties, and 7% of other States. Of the student body, 21% had their pre-legal training at the University of Maryland and 79% had theirs at 62 various other colleges.

Hon. Edwin T. Dickerson, of the part-time faculty, has taken leave of absence for the current academic year from his duties as Lecturer on Contracts in the Evening School. The course is being taught this year by James T. Carter, Esq., also of the part-time faculty, who continues to lecture on Legal Bibliography.

Assistant Professor Russell R. Reno has been granted leave of absence for the current academic year in order to engage in post-graduate study and research in Property law at the Columbia University Law School. Mr. Reno was granted a research fellowship by Columbia University for the purpose of such study. During Mr. Reno's absence, his courses are being handled by certain other members of the faculty and by Mr. Joseph O. Kaiser, A.B., Johns Hopkins, LL.B., Maryland, of the Baltimore Bar, who temporarily joins the part-time faculty as Lecturer on Property.

Officers of the Student Council of the Law School for the current year are: Harold C. Care, Fourth Year Evening Class, President; Anthony W. Kraus, Jr., Second Year Day Class, Vice-President; and E. Louise Brockman, Third Year Day Class, Secretary-Treasurer.
