**Tanya Washington Briche '95** earned a *juris doctor* degree from the University of Maryland School of Law and a master's of law degree from Harvard, where she was a research fellow in social justice and a clinical research fellow at the Criminal Justice Institute. Prior to attending Harvard, she was an associate at Piper & Marbury, LLP, with a practice in the toxic tort defense and commercial litigation departments. She teaches Contracts and LAWR II.

**Paula A. Monopoli** is a professor of law at Southwestern University School of Law. As a visiting scholar at the School of Law during the 2000–2001 academic year, Monopoli taught Estates & Trusts and Estate Planning Seminar and was selected as the part-time teacher of the year. **Mairi N. Morrison** will receive her doctorate in jurisprudence from Oxford University this fall. While at

From 1993 to 1996, Morrison taught at St. Thomas University School of Law in Miami, Fla.
