CONCERNING THE REVIEW

New members of the Student Editorial Board, replacing those who have graduated, are Mary H. Whaley, of the Fourth Year Evening Class; Stedman Prescott, Jr., and Bernard L. Rosen, of the Third Year Day Class; Samuel L. Silber, and George R. Stevens, of the Third Year Evening

Class; Frank I. Davis, Jr., George C. Evering, Frederick J. Green, Jr., and Dorothy E. Holden, of the Second Year Day Class; and Louis C. Cohen, Robert H. Engle, and William F. Mehling, of the Second Year Evening Class.

Those of last year's Board who are still in school are also serving this year. Certain ones of last year's Board, who otherwise would have returned, as well as some of the newly elected members, are absent from school in military or naval service. In such cases, it is planned to carry the names of such members in the list of the members of the Student Editorial Board, with indication of such absence, for the first year thereof. Upon their return to school, these members will then be eligible to rejoin the Board.

NEWS OF THE BAR ASSOCIATIONS

As a result of the recommendation of a special committee of the Maryland State Bar Association, which had acted in concert with a similar committee of the Baltimore City Bar Association, the Maryland State Bar Association, at its June, 1941 meeting, requested Governor O'Connor to appoint a commission to consider the entire judiciary article of the Maryland constitution, and to submit its recommendations, if any seem necessary, for revision of the State's judicial system.

On October 30, 1941, Governor O'Connor announced the appointment of the following as members of the Commission on the Judiciary Article: Hon. Carroll T. Bond, Chief Judge of the Court of Appeals; Hon. Hammond Urner, and Hon. F. Neal Parke, both retired judges of the Court of Appeals; Hon. Eli Frank, Associate Judge of the Supreme Bench of Baltimore City; Charles Markell, Esq., of Baltimore, President of the Maryland State Bar Association; Walter C. Capper, Esq., of Cumberland, former President of the Maryland State Bar Association; Samuel J. Fisher, Esq., and G. C. A. Anderson, Esq., both of Baltimore, respectively the retiring and incoming Presidents of the Baltimore City Bar Association; Harry N. Baetjer, Esq.,

Joseph Bernstein, Esq., and Clarence W. Miles, Esq., of Baltimore City; J. Howard Murray, Esq., of Baltimore County; S. Marvin Peach, Esq., of Prince George's County; Edward D. E. Rollins, Esq., of Elkton, State's Attorney for Cecil County; and F. W. C. Webb, Esq., of Salisbury.

Frederick W. Invernizzi, Esq., Assistant Professor of Law at the University of Maryland School of Law, has been appointed Secretary to the Commission and will be engaged in compiling data for study by the Commission.

NEWS OF THE LAW SCHOOL

The enrollment in the Law School for the current academic year is 167, of whom 117 are in the Evening School, and 50 are in the Day School. The entering Evening School class includes 45 and that of the Day School has 23. Of the entire student body, 62% are residents of Baltimore City, 31% of the Maryland counties, and 7% of other States. Of the student body, 25% had their pre-legal training at the University of Maryland, and the remaining 75% at 62 various other colleges.

As is the case with practically all law schools in the country, the School's enrollment reflects the effect of the military situation. This year's total of 167 represents a drop of 44 from last year's total of 211.

The Evening School course in Evidence, formerly taught by the late Walter L. Clark, Esq., is now being given by Hon. Emory H. Niles, Associate Judge of the Supreme Bench of Baltimore City, who continues also as Lecturer on Admiralty.
