## MAJOR LAW SCHOOL FUND EXPENDITURES

The Annual Fund supported the following School of Law activities during Fiscal Year 1998.

## CLINICAL LAW PROGRAMS

Annual Fund contributions enabled the School of Law to enhance its nationally acclaimed clinical programs in which students represent clients in a wide variety of fields ranging from those with family law problems and criminal defendants to emerging businesses and university scientists.

## COMPUTER TECHNOLOGY

The Annual Fund provided funds for computer technology including hardware, software and staffing necessary for today's law school. Many faculty members use computer "list serves" or "discussion groups" with students so that they can continue discussions beyond the classroom hours.

## CAREER DEVELOPMENT

Annual alumni contributions supported the School of Law's new initiatives to assist in finding jobs. In today's Career Development office, three professionals, all with JD's, help students find meaningful jobs. More than 94 percent of last year's (1997) graduating class were employed six months after graduation.

## STUDENTS AND PROGRAMS

The Annual Fund was the principal financial resource enabling the School of Law to provide opportunities to meet informally with Dean Gifford and other members of the faculty and staff. The funds also supported a student Writing Center to assist students in improving their writing skills, a variety of visiting lecturers and guests to the Law School, and several programs that allowed students to meet and talk with the Dean.

## ALUMNI EVENTS

The Annual Fund supported a variety of events in which the Dean had the opportunity to meet with alumni and bring them up to date about the exciting things happening at the Law School. In addition, it supported the mailing of the "Dean's Letter" to all alumni as well as the *JD* alumni magazine.

## ANTICIPATED USE OF ANNUAL FUNDS FOR FISCAL YEAR 1999

Your Annual Fund gifts are extremely important to the quality of our programs of the School of Law. Your gifts during the upcoming year will continue to support our nationally ranked clinical programs, in which students gain valuable experience representing real clients in actual cases.
