## faculty members

The School of Law welcomes three new faculty members this fall. Professor Marina C. Hsieh will teach Civil Procedure-Legal Method, Civil Procedure and Criminal Procedure. Professor Kimberly A. Moore will lead the law school's efforts in the Intellectual Property area. And Professor Sarah E. Herbert will join the Research and Writing program.

"The University of Maryland School of Law is proud to have three exceptional women with established reputations in legal education joining our faculty this year," says Interim Dean Karen Rothenberg.

Hsieh received her AB, *cum laude*, in government from Harvard University in 1982. She earned a juris doctor in 1988 from Boalt Hall School of Law at the University of California at Berkeley, where she was Order of the Coif. After law school, she clerked for the Hon. Louis H. Pollak, U.S. District Court, Eastern District of Pennsylvania, and Justice John Paul Stevens, of the U.S. Supreme Court.

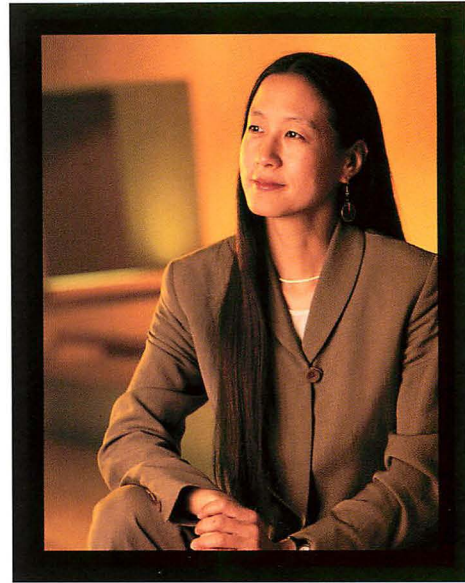
Hsieh was an adjunct faculty member at the Columbia and New York University law schools, and assistant counsel to the NAACP Legal Defense and Educational Fund in New York. As a visiting professor at the University of San Francisco School of Law, she taught Civil Procedure, Criminal Procedure and Race Discrimination. Since 1993, Hsieh has been a professor at the Boalt Hall School of Law, teaching Civil Procedure, Criminal Procedure, Voting Rights and the Asian Law Journal Writing Seminar. In 1997, the graduating class recognized her with the Outstanding Service Award for "extraordinary dedication and commitment to teaching and mentorship."

Moore comes to Maryland from the Chicago-Kent College of Law where, for two years, she was co-director of the Intellectual Property Program. She also created the Chicago-Kent Intellectual Property Moot Court Competition. Earlier this year, her casebook *Patent Litigation and Strategy*, co-authored with the Hon. Paul R. Michel, U.S. Court of Appeals for the Federal Circuit, and Raphael V. Lupo, partner at McDermott, Will & Emery, was published by the West Publishing Co.

Moore is a 1994 graduate of Georgetown University Law Center. She received master's and bachelor's degrees in electrical engineering from the Massachusetts Institute of Technology.

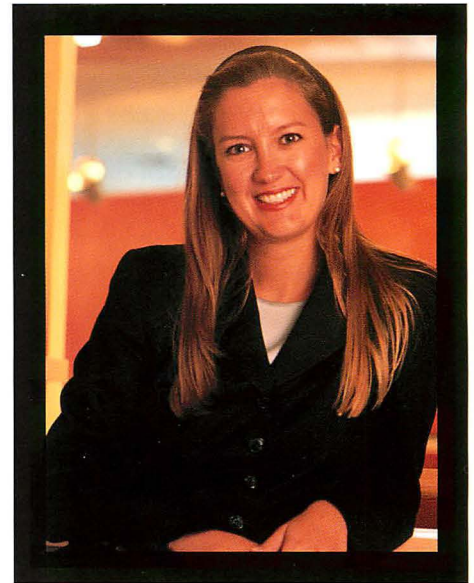
Herbert has been a Lecturer in Law at the University of Buffalo School of Law since 1994, and was among a group of instructors who created that law school's Legal Research and Writing Program. As the Hodgson Russ Fellow for the past two years, she coordinated the program. She will join the Legal Research and Writing Program at Maryland and work with its director, Professor Susan Hankin.

A 1986 *cum laude* graduate of the Harvard Law School, Herbert received her LLM from Columbia University in 1994 and was a Harlan Fiske Stone Scholar. Before joining the faculty at Buffalo, Herbert was an associate with the firm of Carrington, Coleman, Sloman & Blumenthal in Dallas.

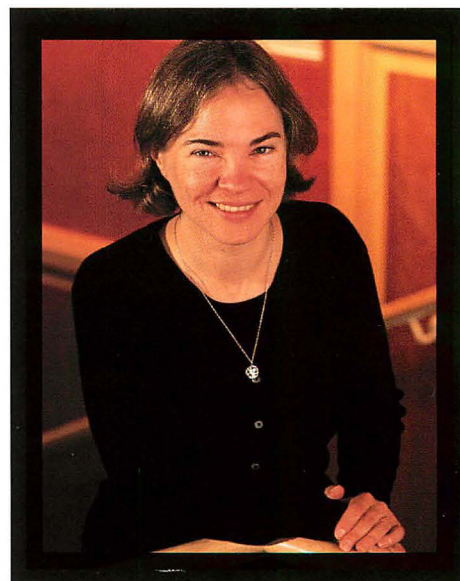
